
I have been directed to communicate to all concerned that "Institutional Academic Integrity Panel (IAIP)" is constituted by the Hon'ble Vice Chancellor, as under in accordance with "University Grants Commission (Promotion Of Academic Integrity And Prevention of Plagiarism In Higher Educational Institutions) Regulations, 2018":

1. Prof. Amita Jain, Dean, Academics - Chairperson
2. Prof. R. K. Garg, Head, Deptt. of Neurology - Member
3. Dr. Ritu Karoli, Sub Dean, Research, RMLIMS, Lucknow - Member
4. Prof. D. N. Upadhayaya, Department of Plastic Surgery - Member

If any member of the academic community of University suspects with appropriate proof that a case of plagiarism has happened in any document, he or she shall report it to the Departmental Academic Integrity Panel (DAIP). Upon receipt of such a complaint or allegation the DAIP shall investigate the matter and submit its recommendations to the Institutional Academic Integrity Panel (IAIP) of the University. The authorities of University can also take *suomotu* notice of an act of plagiarism and initiate proceedings under these regulations. Similarly, proceedings can also be initiated by the University on the basis of findings of an examiner. All such cases will be investigated by the IAIP.

Departmental Academic Integrity Panel (DAIP) shall be formed in all the departments by the respective Heads. The composition of Departmental Academic Integrity Panel (DAIP) shall be as given below:

- (i) Chairman - Head of the Department
- (ii) Member - Senior academician from outside the department, to be nominated by the Hon'ble Vice Chancellor
- (iii) Member - A person well-versed with anti plagiarism tools, to be nominated by the Head of the Department
