Memorandum of Understanding

Between

King George Medical University, Lucknow, India

and

The University of Sydney, Australia

(CRICOS Provider 00026A)

through its **Sydney Medical School**

1. This Memorandum of Understanding (MOU) recognises and affirms that the University of Sydney and King George Medical University (together, the **Institutions**) desire to develop a collaborative arrangement, whereby the Institutions may participate in collaborative teaching, training, research and other agreed activities that further enhance the relationship between the Institutions.
2. In accordance with this MOU, the Institutions will use reasonable endeavours, within their limitations to:
 - a. identify opportunities for joint activities in areas of mutual interest, where areas of mutual interest may include:
 - i. identifying and seeking grant based assistance to support student and staff mobility;
 - ii. identifying research grants to support capacity building and education linkages;
 - iii. student clinical placements in the Regional Institute of Ophthalmology Eye Hospital, Sitapur.
 - b. facilitate visits from one Institution to the other by members of their academic staff for the purpose of participating in teaching, training, research programs and other agreed activities; and
 - c. encourage (on a completely voluntary basis) the exchange of scientific materials, publications and other information between the Institutions.

3. The Institutions agree to designate the following persons as administrative focal points for any administrative aspects of this MOU:

4. This MOU is in no way intended to create legal or binding obligations on either Institution and serves only as a record of the Institutions' current intention to enhance the relationship of the Institutions going forward.
5. Before any of the activities set out in this MOU are implemented, the Institutions must enter into formal and binding agreement(s) (separate from this MOU) with each other which will detail the specific form and content of the activities and address the responsibilities and rights of each Institution in relation to those activities. The Institutions agree to negotiate the terms of any such agreement(s) in good faith and for the purpose of enhancing the relationship of the Institutions.
6. The term of this MOU commences on the date of signature by both Institutions, and remains in full force and effect for 3 years unless it is earlier terminated by either Institution with written notice.
