MINUTES OF THE MEETING

Second meeting of anti-ragging committee was held on 21/12/2021 at Board Room, Admin Block based on the complaint number ARCC/UP 6931 dt 4/12/21, received from Anti-Ragging Helpline stating that they have received the complaint from Junior Resident-1 of Orthopaedic Emergency Unit, Trauma Centre, KGMU regarding the ragging done by Dr. [Name], Dr. [Name], Dr. [Name] and Dr. [Name], Junior resident 2 of MS orthopaedic batch 2019 of KGMU

The member of anti-ragging committee enquired from the staff of orthopaedic emergency unit, trauma centre regarding occurrence of any objectionable activity as mentioned in the complaint done. The committee enquired Miss [Name] (Staff nurse), [Name] (Ward boy), [Name] (Ward aaya) and F [Name] (Safai karmachari) who were posted in Orthopaedic emergency unit, Trauma centre on 3rd December 2021 in evening shift of 2pm to 8 pm. The staff clearly denied of any such incidence happened in their duty hours in the ward and gave their statements accordingly in written which are being attached with the minutes.


The committee also reviewed the CCTV footage of Orthopaedic emergency unit of 3rd December 2021 from P.R.O office, Trauma centre of the duration 2pm to 8pm. The CCTV footage was thoroughly seen and did not show any evidence of physical or mental abuse in the ward.


