Sir,

The following incident happened to me on 21<sup>st</sup> August, 2022, at 4:50 A.M.

I had finished my studies in the reading room of K.G.M.U. (Entered reading room at 2 A.M.) and was heading towards my hostel. At this time when I was returning and was walking over beside the parking of P.S.M. department. Then I heard a voice from my back, "[Abusive language], kaha jaa raha hai bag ke sath, idher ah". I turned my back and saw a guard in uniform. [The guard is identified as ] who was at duty there that day. I asked him, "Why are you calling me in abusive language". I said an abusive word and said, "I am a student here, what's the need to call me". I was talking to the guard, and didn't know there were people sitting over the ambulance<sup>van</sup> who were calling me, they shouted and got off the van. I asked the guard who were they, the guard said, "Ye doctor sekeb hain". And I realised that they must be some seniors. I said "sorry boss I didn't know it was you, I thought the guard was calling me in abusive language". They didn't listen to any of this and the main accused [ , SR 2 of Pediatrics department, K.G.M.U.] who was highly intoxicated [Alcohol] as he had bad alcohol breath came near me and slapped me on my face.



And he continued to slap me, asking my <sup>name</sup> calling racist slurs and again and again saying, "Job kuch aukat ke ban go jao to goalidena". when I clearly did not abuse him.

They slapped me so many times that my face started to hurt and cheeks swelled. I was scared, just like a person being mugged I did not retaliate fearing that they would beat me up worse. They then started pulling my clothes at this time there were only 2 people, but a third person came to the scene one of their friends. They said to me to take off my clothes, ~~after~~ the fear of ~~too~~ tearing up of my clothes I obliged and took off my clothes. A scooter was passing by with my batchmates at that time, they showed them off. Then said to put on my clothes. Then the person slapped me again and told me to become a ~~merga~~ <sup>merga</sup>. After that he caught another of my batchmate, <sup>CABHIDEK SINGH</sup> and after sometime until I cried up in front of them, they left me.

### Accusations:-

- ① Slappings [Assault, Mugging], Evidence: Video by guard
- ② Physical damage to face [Assault]: Photo evidence
- ③ Forcing to Strip [Ragging]: Evidence: Batchmates who saw that
- ④ Forcing to become ~~merga~~ <sup>merga</sup> [Ragging]
- ⑤ Threatening ~~me~~ [Fear mongering] and saying that I shouldn't complain
- ⑥ Guard saw everything, did nothing [Failure of Administration to protect students]

I was traumatised by this event and if I endure any mental or physical trauma then I hold Sunil Bhatt and KGMU administration as responsible.
